

NOTICE TO MARINERS Transiting the following locations:

NOAA/National Ocean Service/Center for Operational Oceanographic Products and Services has deployed oceanographic instrumentation in trawl-resistant bottom mounts (TRBM, m-TRBM, ES-2) or subsurface taut-line moorings (SUBS, DWM) within the Strait of Juan de Fuca and Puget Sound, WA, in the following positions. The equipment will remain in place until at least until August 26th 2016. The stations should not have any presence on the surface. The SUBS do however extend up to 38 meters above the seafloor. This equipment will be used for a currents circulation study to improve current predictions, and may help save lives and property.

The SUBS and Deep Water moorings are NOT TRAWL RESISTANT and may cause damage to fishing gear.

If brought to the surface, please notify NOAA by calling 1-800-FOR-NOAA (367-6622). If possible return gear to original location.

Please take care to avoid disturbing the instruments between April 19th and August 26th 2016.
