11-K-1 NAVIGABILITY AND JURISDICTIONAL DETERMINATIONS

Ref: (a) 33 C.F.R. Part 2

1. <u>PURPOSE</u>. The purpose of this section is to set procedures to be used in accumulating information and processing navigability and jurisdictional determinations for waters within the District. This section also provides information about legal and administrative navigability determinations made for various bodies of water within the geographic limits of the District.

2. DISCUSSION.

- a. Reference (a) provides the legal standards for determining the extent of Coast Guard jurisdiction over waters within the District. In those instances where the application of these standards yields an obvious result regarding the extent of Coast Guard jurisdiction, local unit commanding officers should exercise jurisdiction accordingly.
- b. Anytime a unit commanding officer or division/branch chief is uncertain about the extent of Coast Guard jurisdiction within their area of responsibility, they should request an administrative navigability determination from the District Legal Officer. The District Legal Officer will express his/her findings in a written document, which will become available to the public (see 11-K Exhibit 1).
- c. Depending on the novelty of the legal issues involved, the extent to which the facts are in question, and the extent of public interest, the District Commander may forward a proposed determination, together with all relevant material, to the Chief Counsel or to the Commandant for a determination.

3. PROCEDURE.

- a. When a navigability or jurisdictional determination is required, the cognizant unit commanding officer or division/branch chief should, as a minimum, use whatever information gathering methods are necessary to compile and thoroughly and authoritatively present the information called for by the form attached as 11-K Exhibit 2. Users as necessary should reproduce this form.
- b. The information gathering process should usually include contacting and seeking assistance from all non-Coast Guard parties involved with the activity requiring the jurisdictional decision. As a minimum, a representative of the cognizant unit, division, or branch should visit the site for which the navigability determination is requested. The physical condition of the waterway should be documented using photographs, diagrams, charts, sounding, and/or tidal data reports, etc. Attempts should be made to contact representatives of the current and future users of the waterway. Information about the historical uses of the waterway should be obtained from local museums, libraries, and historical societies. Other federal agencies (e.g., Army Corps of Engineers, Environmental Protection Agency, Department of the Interior, etc.) exercising jurisdiction over the waterway should also be consulted regarding determinations they have made for the purposes of their regulatory jurisdiction. Information regarding proposed waterway improvements and/or alternative uses should also be obtained. The completed form and any additional documents and comments by the division/branch should be submitted to the District Legal Officer.
- c. All information should be compiled and submitted to the District Legal Office using 11-K Exhibit 2.

The District Legal Officer will evaluate the materials and make a navigability determination using the legal standards established by reference (a). The Legal Officer will provide a written determination to the requesting unit or division/branch chief. All new determinations will be incorporated into 11-K Exhibit 1 upon the next revision of the District SOP.

- 4. Navigability of Waterways Thirteenth Coast Guard District. 11-K Exhibit 1 is designed to provide internal guidance as to the Coast Guard's determinations concerning the navigability of waters in the District for the purposes of exercising Coast Guard jurisdiction. It includes formal determinations made by the Commandant, by the District Commander, and by the courts and Congress. No attempt has been made to list those additional waterways "subject to the jurisdiction of the United States" as that phrase is used in the Federal Boating Safety Act 46 U.S.C. § 4301 et seq. Use of this list is subject to the following guidelines:
 - a. Waterways not contained on this list may or may not be navigable. Their absence indicates that the Coast Guard, the Courts, or Congress have made no determination concerning their navigability.
 - b. Waterways which are under tidal influences, whether contained on this list or not, are considered navigable by the Coast Guard to the extent of tidal influence.
 - c. When an "X" is shown under "NAV CG", this indicates that the Coast Guard considers either the entire waterway or certain portions of the subject waterway navigable. Any known limits may be explained in the adjacent comment.
 - d. Pursuant to reference (a), the public has a right to obtain information regarding Coast Guard navigability determinations. However, members of the public may be interested in using Coast Guard navigability determinations for a number of purposes unrelated to Coast Guard jurisdiction (e.g., admiralty and maritime jurisdiction, application of state and federal laws not enforced or administered by the Coast Guard, local property laws, etc.) Often times, members of the public do not appreciate that Coast Guard navigability determinations are made only for the purposes of exercising specific types of regulatory jurisdiction over specific types of waters. For this reason, field units should not release copies of 11-K Exhibit 1 directly to the public. All questions regarding navigability of waters within the District and all requests for copies of 11-K Exhibit 1 should be referred to the District Legal Office. The District Legal Office will respond directly to the requesters.

NAVIGABILITY DETERMINATIONS FOR THE THIRTEENTH DISTRICT

Attached is a listing of navigability determinations for waters in the Thirteenth Coast Guard District. This listing is maintained in accordance with Title 33, Subpart 2.10 of the Code of Federal Regulations. It includes formal determinations made by the Coast Guard, as well as those made by the courts or Congress. No attempt has been made to list those waterways "subject to the jurisdiction of the United States" as that phrase is used in the Federal Boating Safety Act (Title 46 United States Code § 4301 et. seq.). Additionally, the extent of navigable waters under the Clean Water Act (Title 33 United States Code § 1321 et. seq.) may be broader. Except for waterways determined to be "navigable waters of the United States", this list does not list waters otherwise "Subject to the Jurisdiction of the United States" as that term is used in Title 33 Code of Federal Regulations § 2.05-30(b), (c), & (d).

Waters that are subject to tidal influence, whether listed or not, are considered navigable for the purposes of general Coast Guard jurisdiction to the limits of tidal influence. (See Title 33 Code of Federal Regulations § 2.05-25).

Where an "X" is shown under "NAV CG", this indicates that either the entire waterway or certain portions of it are considered to be navigable. Limits on the extent of navigability will be explained in the comment. **Navigability determinations for some waterways may be for a limited purpose** (i.e., bridge permitting, recreational vessel fee, etc.). These limitations will also be explained in the comments.

Waterways not contained on this list may or may not be navigable. There absence indicates that no determination has been made by the Coast Guard, the courts, or by Congress concerning their navigability. This list is subject at change at any time should a new or contrary determination be made.

Navigability determinations made by the Coast Guard are for the purposes of exercising Coast Guard authority and jurisdiction only. They should not be construed as determinative of jurisdiction under admiralty and general maritime law, state law, or for jurisdiction by other federal agencies (such as the Army Corps of Engineers).

Navigability Determinations for Thirteenth Coast Guard District

NOTE: Territorial seas (i.e., those waters within a belt, three nautical miles wide, that are adjacent to the coastlines of Washington and Oregon and seaward) and of the Thirteenth Coast Guard District which are subject to tidal influence (e.g., Puget Sound), whether specifically noted in the following list, are considered navigable waters for purposes of Coast Guard jurisdiction.
